### 2. SUBJECT OF THE AGREEMENT

2.1. The subject of this Agreement is to award a financial contribution - grant to the Beneficiary for the exclusive purpose of supporting Beneficiary's educational and/or scientific activities during his/her stay at

..... /hereinafter referred to as the "**Host institution**"/ in accordance with Beneficiary's funding request as approved by the Executive Committee of the Association.

The Beneficiary accepts the financial contribution and undertakes to carry out the academic mobility as described in the Description of the Grant Scheme (Annex I), acting on his own responsibility.

2.2. The Beneficiary accepts the terms and conditions laid down in this Agreement. This Agreement can be modified only by mutual consent of both parties in the form of a written supplement.

### **3. FINANCIAL PROVISIONS**

### **5. BENEFICIARY'S OBLIGATIONS**

5.1. The Beneficiary commits to:

- use the grant for the intended purpose set out in this Agreement
- arrange his/her visa and other formal requirements connected with his/her stay abroad before signing of this Agreement
- submit a final report on his/her project work at the Host institution to the representative of the Association at his/her home institution within 2 weeks after completion of his/her academic mobility period
- submit a letter of confirmation from the Host Institution certifying completion of the academic mobility period and specifying its duration to the Secretary General of the Association within 2 weeks of his/her return
- pay back the financial contribution - grant partially or in full if the academic mobility is cancelled or shortened or if he/she fails to comply with this Agreement.

5.2. The Beneficiary gives permission that his/her personal data can be used by the Association for administrative purposes.

The Association commits to ensure that the Beneficiary's personal data are treated with confidentiality.

**1. FINAL PROVISIONS**

- 6.1. The financial contribution – grant is governed by the terms and conditions laid down in this Agreement, the rules of the Association and the applicable laws of the Slovak Republic.
- 6.2. This Agreement has been drawn up in three copies, of which two are to be retained by the Association and one is to be retained by the Beneficiary.
- 6.3. This Agreement comes into effect and becomes valid on the day of its signing by both parties to the Agreement.
